- 1. A completed application with payment of application fee:
 - a. This application fee covers the expense of application, jurisprudence exam administration, and licensing fees through June 30 of the upcoming odd year, at which time you will receive a renewal form for the upcoming renewal period.
 - b. You will <u>not</u> be required to submit continuing education upon your first renewal.
 - c. Please make check or money order payable to the Nevada State Veterinary Board.
 - d. WE DO NOT ACCEPT CASH.
 - e. You MUST complete the child support information portion of the application even if you are not under a court order for child support.
- 2. A 2-inch by 2-inch photograph (Facing forwards, no sunglasses, no hats, or other items covering the face)
- 3. If licensed or registered in another state, Letters of Good Standing from the licensing agency of each state in which you <u>are currently</u> licensed or have <u>ever</u> been licensed. Please see the FAQ page for letters of good standing that we accept through online verification.
- 4. <u>Veterinary Graduates of Schools that are AVMA Accredited</u>
 - a. An official copy of your transcripts showing the completion of your education or a notarized copy of your diploma.
 - 1. We accept digital versions of documents provided they are sent directly from the school.
 - 2. If you are having a transcript sent, it must indicate that you have been awarded the degree.
- 5. <u>Veterinary Graduates of Schools that are NOT AVMA Accredited</u>
 - a. Proof of completion of the AVMA ECFVG (Education Council on Foreign Veterinary Graduates) program. If you are currently enrolled, but have not completed the ECFVG program, please contact our office or go to the VGAL (veterinary graduate awaiting licensure) application for more information.
 - b. Nevada does not accept the PAVE program for licensure as a veterinarian at this time.
- 6. <u>Passing score on the NAVLE or NBE/CCT</u>
 - a. Official score from the AAVSB showing a passing score of the NAVLE or NBE/CCT
- 7. <u>Diplomates ONLY: Verification from the governing body of your specialty, verifying your status</u> <u>as a diplomate in that field.</u>
- 8. Passing score of a 90% on the Nevada State Jurisprudence Examination.
 - a. You will receive an email with instructions to complete the exam once we have received all other components of your application. Once you have received a passing score, your license will be automatically completed, and you will receive information regarding your credentials.
