## Case No. 03-2022DVM-10 ACCUSATION AND NOTICE OF HEARING

The Nevada State Board of Veterinary Medical Examiners, by and through its Executive Director Jennifer Pedigo, makes the following accusation against Terry Muratore, D.V.M. (License No. 551-A) which shall serve as an accusation pursuant to NAC 638.240 and as a notice of intended action pursuant to NRS 233B.127(3). The pertinent facts and law regarding this accusation are as follows:

**BEFORE THE NEVADA STATE BOARD OF** 

**BOARD OF VETERINARY MEDICAL EXAMINERS** 

I.

The Board has jurisdiction over this matter because Respondent Terry Muratore, D.V.M. is licensed by the Board to practice veterinary medicine in Nevada (License No. 551-A) and was so licensed at all times pertinent to the instant matter. At all times pertinent to the instant matter, Dr. Muratore practiced veterinary medicine at Legacy Animal Hospital in Henderson, Nevada.

II.

On March 7, 2022, a Board inspector performed a hospital inspection at Legacy Animal Hospital. During the course of the inspection, medical records indicated that Dr. Muratore routinely had not administered rabies vaccinations to animals at his practice but had executed for those same animals certificates of vaccination, including rabies tag numbers, used for various purposes indicating that he had administered to them rabies vaccinations.

III.

On March 11, 2022, the Board's President signed an Order of Summary Suspension of License to Practice Veterinary Medicine in the instant matter. The Order of Summary Suspension was personally served upon Dr. Muratore on March 14, 2022.

On March 14, 15, and 16, 2022, members of the Board's staff conducted an investigation at Legacy Animal Hospital during which they interviewed members of the staff of Legacy Animal Hospital and reviewed and copied numerous records relevant to the investigation.

IV.

V.

The investigation by the Board's staff on March 14, 15, and 16, 2022 found that Dr. Muratore had engaged in a practice of not vaccinating some animals in his practice but then executing for those same animals certificates of vaccination whereby he certified that he had administered rabies vaccinations to those animal. The investigation by the Board's staff on March 14, 15, and 16, 2022 found over 140 animals for which Dr. Muratore had certified that he had administered a rabies vaccination and for which he had not, in fact, administered a rabies vaccination. A table listing particulars regarding the animals for which Dr. Muratore had certified that he had administered a rabies vaccination and for which he had not, in fact, administered a rabies vaccination is attached as Exhibit A and is incorporated herein by this reference.

### VI.

In order to protect the health, safety, and welfare of the general public and animals, Nevada law requires that cats, dogs, and ferrets be vaccinated against rabies. NRS 441A.410 requires that the State Board of Health promulgate regulations governing the control of rabies, and pursuant to that authority, NAC 441A.410-441A.445 set out regulations governing the control of rabies. In particular, NAC 441A.440 sets out requirements for a certificate to be issued by a veterinarian when the veterinarian has vaccinated an animal for rabies prevention.

#### VII.

In order to protect the health, safety, and welfare of the general public and animals, Nevada law requires that every county, township, city, and town enact ordinances providing for rabies prevention. NRS 244.358; NRS 268.427; NRS 269.227. Pursuant to this authority, every jurisdiction that might be

served by Dr. Muratore (i.e., Clark County, City of Las Vegas, City of Henderson, and City of North Las Vegas) have all enacted ordinances requiring that cats, dogs, and ferrets be vaccinated for rabies by a licensed veterinarian and that the veterinarian who administers the vaccination must issue thereafter a certificate and a metal tag for each animal vaccinated.

### FIRST CAUSE OF ACTION

#### VIII.

In certifying that he had administered rabies vaccinations to animals that he had not, in fact, vaccinated, Dr. Muratore violated Nevada Revised Statutes (NRS) 628.140(1) and/or NRS 638.140(8) and/or NRS 638.1402(4) and/or NRS 638.1408(4) and/or Nevada Administrative Code (NAC) 638.048(1) and/or NAC 638.048(2) and/or NAC 638.048(4). Each failure to vaccinate an animal and each certification of having done so constitutes a separate violation of the statutes and regulations cited within this paragraph and, therefore, constitutes a separate and distinct cause for discipline.

WHEREFORE, the Board's Staff requests that the Board impose such discipline as it deems just, necessary, and appropriate in this matter.

### NOTICE OF HEARING

PLEASE TAKE NOTICE that the hearing of this matter is scheduled to be held at 9:00 a.m. or as soon thereafter as possible on April 22, 2022 at the Viticus Group-Oquendo Campus, 2425 East Oquendo Road, Las Vegas, Nevada, 89120. The hearing shall be held in accordance with the

provisions of NRS and NAC chapters 233B and 638 to determine whether discipline should be imposed against Respondent in relation to the above Accusation. At the hearing, the Board may go into closed session to consider the character, alleged misconduct, professional competence, physical or mental health of the Respondent. This Notice of Hearing shall serve as the notice required by NRS 241.033, NRS 622A.300, and NAC 638.260.

Pursuant to NAC 638.250, you may request a full hearing before the Board by filing within 15 days of the date of your receipt of this Accusation a request for a hearing with the Board's office at the within address. Pursuant to NRS 639.250, if you request a full hearing, you must file an answer with the Board within 20 days of the date of your receipt of this Accusation in which you may address the specific allegations made against you in the Accusation. Pursuant to NAC 638.250, the Board may conduct a hearing and render disciplinary action against you even if you do not file a request for a hearing and an answer.
